# **Officer Reports**

Chairperson

First Friday - Attendance at First Friday exhibits is continuing to decrease. Thirty people attended on March 3, 2017. Previously attendance numbered in the 120 - 200 range.

Vice Chairperson -- Volunteer Update - Our present letter to recruit volunteers has not been effective. It will be updated. Plan is to encourage parents with children in our classes to volunteer at the Art House as well. Volunteer document will be a separate letter from the membership letter.

#### Financials -

As of 2.28.2017, current revenue is \$53,656.36, of which \$45,840.50 is from classes and programs. Assuming the same trend for the next four months of the fiscal year, it is anticipated that revenue will be approx. \$80,475. Revenue from Art in the Sun traditionally brings in approx. \$40,000 for a total expected revenue of approx. \$120,000. Expected wages and expenses are projected at \$109,000. Therefore, expected revenue should slightly exceed expected expenses by year end (6.30.17) if current trends continue.
