# 6. CASES

CASE #1 GRAPHIC VISIONS/STEFANA BOUTIQUE 122 W. MAIN STREET

**SIGN** 

Sandy Mustonan was present on behalf of Graphic Visions for the application for the signs for the Stefana Boutique at 122 W. Main Street. She referenced a review letter from Mr. Penn, dated February 6, 2013; and provided a sample of the sign foam, noting it was the same material used for the sign next door to the subject business. She provided the following color samples:

Sherwin Williams paint: 6989, Domino; 6385, cream color called Dover White; the illustration included metallic copper for the lettering, 110L; tiny detail on crown, dimensional, using silver leaf (they do not have a specific number, and it comes in sheets).

The Historic District Commission reviewed the submission and did not have questions.

CASE #2 GRAPHIC VISIONS/KUMON 114 MAINCENTRE

SIGN

Sandy Mustonan was present on behalf of Graphic Visions for the application for a new sign at 114 Maincentre; for the business, Kumon. She referenced Mr. Penn's review letter dated February 12, 2013. She described the sign, and said the background color is Major Blue: 6795; and the white is Pure White: 7005 pure white; both Sherwin Williams.

CASE #3 GINNARD CONSTRUCTION 228 WEST STREET

ROOF REPLACEMENT

Mr. Ginnard was present regarding the emergency roof repair and replacement at 228 West Street. He showed samples of the proposed 3 tab shingles; the color is Moire Black; and he showed a photograph of the existing house, as included in the packet. He said they stopped producing the existing shingles about 30 years ago.

**Motion by Hoffman, supported by Luikart,** to grant a Notice to Proceed referencing the Northville Historic District Design Standards 5.9 for asphalt shingles, and 5.18 for color, as presented by the Applicant.
